

**TIMOTHY F. GEITHNER TO JOIN WARBURG PINCUS
AS PRESIDENT AND MANAGING DIRECTOR**

New York, November 16, 2013 – Warburg Pincus, a leading global private equity firm focused on growth investing, today announced the appointment of Timothy F. Geithner as President and Managing Director. Mr. Geithner also will be a member of the firm’s Executive Management Group.

He first joined the Department of Treasury in 1988 and worked in a variety of positions in three administrations. From 1999 to 2001, Geithner served as Undersecretary of the Treasury for International Affairs, under Secretaries Robert E. Rubin and Lawrence H. Summers. Mr. Geithner was Director of the Policy Development and Review Department at the International Monetary Fund from 2001 until 2003. Previously, he worked for Kissinger Associates, Inc.
